ORDERS OF THE MANAGING DIRECTOR, KRDCL AND APPELANT AUTHORITY MEETING HELD ON 23-04-2021 PERTAINING TO PACKAGE-3 UPGRADATION AND MAINTENANCE OF HIGH DENSITY CORRIDOR IN BENGALURU.

CASE : M/s. UDAYSHIVAKUMAR, INFRA PRIVATE LIMITED- Applicant V/S CHIEF ENGINEER KRDCL- Employer

Applicant M/s. Udayshivakumar Infra Private Limited represented by Shri. B.S.Raghu submitted to the authority that their technical bid for package-3 was rejected by the tender scrutiny committee meeting held on 21-04-2021 for the reason that maintenance work executed details are not submitted.

Further, applicant submitted that they have submitted a certificate issued by Executive Engineer, National Highway Division, Tumkuru that the agency was executed the work of periodical renewal (PR) from Km 20.00 to Km 75.34 on NH 206 Tumkuru - Honnavar section (Job NCTA/ 206/ KNT/ PR/ 2016-17/ 07) and the same has been uploaded in e-procurement portal.

The Employer representative Sri.S.M.Rajgopal Executive Engineer, KRDCL submitted that the nature of work was periodical renewal of the bituminous surface, not indicating anything about the maintenance nature of work. Hence, their certificate was not considered for the evaluation.

Sri B.S.Raghu contended that the work is purely maintenance work and requested the Authority to consider the same for evaluation.

Executive Engineer, KRDCL submitted that the Executive Engineer, National Highway Division, Tumkuru vide letter dated 22-04-2021 has confirmed the contention of the applicant and the work executed by the agency involves maintenance nature of work. Further, Executive Engineer, KRDCL exhibited the certificate.

Authority enquired with Executive Engineer, KRDCL that if we consider this certificate of confirmation, will the applicant qualifies the conditions stipulated for technical evaluation. Executive Engineer, KRDCL replied that the agency will qualify the conditions stipulated for technical evaluation considering the letter of confirmation of Executive Engineer, National Highway Division, Tumkuru.

: ORDERS :

On hearing the applicant and employer arguments, the Appellant Authority is of the opinion that the applicant submissions can be considered. Accordingly the appeal filed by the applicant is allowed and orders that the applicant M/s. Udayshivakumar Infra Private Limited technical bid for package-3 of High Density Corridors is technically approved and directed the respondent CE KRDCL to open the financial bid of the applicant.
